## 2011 Peach Buyers, A Source for Peach Information Now Available

The 2011 edition of the *Peach Buyers Guide* is now available from the New Jersey Peach Promotion Council and the Rutgers New Jersey Agricultural Experiment Station. According to Rutgers Agricultural Agent, Jerry Frecon, author of the guide, "this year's guide is 72 pages with information for prospective wholesale buyers on where and how to buy and handle New Jersey peaches and nectarines." "The guide lists in alphabetical order all "Peach Council" member growers and shippers of New Jersey peaches, including their brands and general



information on what and how they ship," said Mr. Frecon. This section has been completely updated for



easier use and placement on the regularly updated web site at <u>www.jerseypeaches.com</u>. New pages also list peach grower retailers and New Jersey famers markets of New Jersey Peaches.

Over the years the guide has been an important source of information for the media because it provides details and statistics on the peach industry. Color pictures of some of the most important new varieties are highlighted along with details on when they are available for buyers. A multi-color availability chart explains this in detail.

A new sections on food safety on peach farms has been included. This sections describes food safety practices on peach farms.

Information is included on the Jersey Fresh Promotional program for peaches and the Quality-Grading program run by the New Jersey Department of Agriculture. Details on officers and directors of the New Jersey Peach Promotion Council are listed along with an outline of plans for the 2011 promotional program on peaches.

For merchandisers, the guide contains information on how to store and handle New Jersey peaches. The opening page of the guide explains why everyone should buy New Jersey Peaches. Buying New Jersey peaches helps to preserve peach farms and open space in the Garden State.

# Allende Sworn in to Seat on State Board of Agriculture

(TRENTON) – South Jersey peach farmer, Francisco J. Allende, was sworn in to a seat on the New Jersey State Board of Agriculture during a board meeting at Dorsett Farm in Woolwich Township May 25.

Allende was selected for the position by the delegates attending the February 2010 New Jersey State Agriculture Convention. He was then nominated by Governor Chris Christie and approved by the state Senate. His term on the board will expire in 2014.

"Francisco Allende brings a wealth of experience and a unique perspective to the State Board of Agriculture," said New Jersey Secretary of Agriculture Douglas H. Fisher. "His experience and expertise will be great assets as the Board tackles issues that will impact the future of the agriculture industry."

Allende is co-manager and co-owner of Gala farms in Salem and Cumberland Counties, with more than 200 acres of peaches planted. He is General Manager and co-owner of Sunny Valley Int., Inc., a Glassboro fresh fruits and vegetables distributor, as well as co-manager and co-owner of Eastern Propak, a Glassboro storage and packing facility.

"At this time my main goal is to learn as much as possible and broaden my knowledge and understanding of New Jersey Agriculture as a whole," said Allende.

Allende is a director and past chairman of the New Jersey Peach Promotion Council, a director on the New Jersey Blueberry Growers Industry Advisory Council, and a Board member of the U.S. Highbush Blueberry Council.

Allende has a degree in commercial engineering from the University of Santiago in Chile. He currently resides in Moorestown.

The State Board of Agriculture, comprising eight members, is the policy-making body of the New Jersey Department of Agriculture. Its members serve for four years, with two members being replaced each year. By law, at least four of its members must represent the top commodity groups in the state.
